

RESOLUTION NO. 2024-233

RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF SAN BERNARDINO, CALIFORNIA, AUTHORIZING THE ACTING CITY MANAGER TO ACCEPT THE FY 2024/25 TOBACCO GRANT BY SIGNING THE DEPARTMENT OF JUSTICE MEMORANDUM OF UNDERSTANDING AND THE INTERIM DIRECTOR OF FINANCE AND MANAGEMENT SERVICES TO AMEND THE FY 2024/25 ADOPTED BUDGET APPROPRIATING \$301,015 IN BOTH REVENUE AND EXPENDITURES.

WHEREAS, the City of San Bernardino has been awarded the FY 2024/25 California Department of Justice Tobacco Grant funding in the amount of \$301,015; and,

WHEREAS,. The City will use grant funding to continue tobacco enforcement and education programs.

BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF SAN BERNARDINO AS FOLLOWS:

SECTION 1. The above recitals are true and correct and are incorporated herein by this reference.

SECTION 2. The City Manager is hereby authorized to execute the grant agreement between the City of San Bernardino and the California Department of Justice and accept the FY 2024/25 Tobacco Grant in the amount of \$301,015.

SECTION 3. The Interim Director of Finance and Management Services is hereby authorized to amend the FY 2024/25 Adopted Budget increasing revenue and expenditures by \$301,015.

SECTION 4. That the City Council finds this Resolution is not subject to the California Environmental Quality Act (CEQA) in that the activity is covered by the general rule that CEQA applies only to projects which have the potential for causing a significant effect on the environment. Where it can be seen with certainty, as in this case, that there is no possibility that the activity in question may have a significant effect on the environment, the activity is not subject to CEQA.

SECTION 5. Severability. If any provision of this Resolution or the application thereof to any person or circumstance is held invalid, such invalidity shall not affect other provisions or applications, and to this end the provisions of this Resolution are declared to be severable.

SECTION 6. Effective Date. This Resolution shall become effective immediately.
