

RESOLUTION NO. 2024-091

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN BERNARDINO DECLARING ITS INTENT TO ISSUE TAX EXEMPT OBLIGATIONS TO BE USED TO REIMBURSE EXPENDITURES PRIOR TO THE ISSUANCE OF SUCH BONDS

WHEREAS, the City of San Bernardino (the “City”) plans to issue tax-exempt lease revenue bonds (the “Obligations”) to fund the seismic retrofit and renovation of City Hall (the “Project”); and

WHEREAS, the City reasonably expects to use a portion of the proceeds of the Obligations to reimburse the City for expenditures on the Project.

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF SAN BERNARDINO AS FOLLOWS:

SECTION 1. Declaration of Official Intent. The City hereby declares its official intent, subject to the further approval of this City Council, to use up to \$30,000,000 million of the proceeds of the Obligations to reimburse for expenditures on the Project. It is intended that this Resolution shall constitute a declaration of “official intent” within the meaning of Section 1.150-2 of the Treasury Regulations promulgated under Section 150 of the Internal Revenue Code, as amended.

SECTION 2. Other Approvals. The adoption of this Resolution shall not bind the Authority to proceed with execution and delivery of the Obligations until and unless all other necessary actions and approvals are taken or received in accordance with all applicable laws, at the discretion of the City.

SECTION 3. Effective Date. This Resolution shall take effect from and after the date of its passage and adoption.
