#### **Recommendation:**

It is recommended that the Mayor and City Council of the City of San Bernardino, California,

1. Adopt Resolution No. 2025-306 approving the Road Maintenance and Rehabilitation proposed project list for submittal to the California Transportation Commission and adopting a list of projects for Fiscal Year 2025/26 to be funded by Senate Bill 1: Road Repair and Accountability Act of 2017; and
2. Adopt Resolution No. 2025-307 authorizing the Interim Director of Finance and Management Services to amend the FY 2025/26 Capital Improvement Plan, recording supplemental appropriations in the amount of \$5,943,708.00 in SB1 Fund and \$1,409,042.90 in Measure I Fund, for a total additional appropriation of \$7,352,750.90 for Street Rehabilitation – Major Arterial Entrances to the City (Project No. 13655) Project.

#### **Executive Summary**

This report recommends that the Mayor and City Council adopt resolutions approving the City of San Bernardino's FY 2025/26 list of road maintenance and rehabilitation projects eligible for funding under Senate Bill 1 (SB1), the Road Repair and Accountability Act of 2017. Approval is required to maintain the City's eligibility to receive an estimated \$5.94 million in Road Maintenance and Rehabilitation Account (RMRA) funding from the State. Additionally, the report seeks authorization for the Interim Director of Finance and Management Services to amend the FY 2025/26 Capital Improvement Plan to appropriate a total of \$7.35 million—including \$5.94 million in SB1 funds and \$1.41 million in Measure I funds—to support the Street Rehabilitation – Major Arterial Entrances to the City project. These improvements align with the City's strategic goals for infrastructure asset management and address critical pavement maintenance needs identified in the

City's pavement management plan.

## **Background**

### **Senate Bill (SB) 1**

On April 28, 2017, the Governor signed Senate Bill (SB) 1 (Beall, Chapter 5, Statute 2017), which is known as the Road Repair and Accountability Act of 2017 to address basic road maintenance, rehabilitation, and critical safety needs on both the state highway and local streets and road system. SB1 increases per gallon fuel excise taxes; increases diesel fuel sales taxes and vehicle registration fees; and provides for inflationary adjustments to tax rates in future years.

On November 1, 2017, the State Controller deposited various portions of new funding into the newly created Road Maintenance and Rehabilitation Account (RMRA). A percentage of the new RMRA funding was apportioned by formula to eligible cities and counties pursuant to Streets and Highways Code (SHC) Section 2032 (h) for basic road maintenance, rehabilitation, and critical safety projects on the local streets and road systems.

- Annually, on July 1st, the City of San Bernardino, along with all other eligible California agencies, submits a work plan to the California Transportation Commission (CTC) committing the following fiscal years RMRA funding to a specific pavement preservation project in the coming year or in a future year if the City so desires. The submission of the work plan maintains the City's eligibility to garner RMRA funding during the forthcoming fiscal year. Without this commitment of RMRA funds the City loses its eligibility to collect RMRA funding through the State Controller's Office (SCO).

## **Discussion**

The City anticipates receiving an estimated \$5,943,708 in SB1 funds in FY 2025/26, which will be used to support the repair, rehabilitation, and improvement of the City's street segments identified on the SB1 FY 2025/26 project list. To remain eligible to receive such funds through RMRA program, the City, through its Measure I funds, is required to allocate at least \$1,167,244 on an annual basis.

Every year on July 1<sup>st</sup>, the City is required to adopt a resolution identifying projects using RMRA allocation and submit this list of adopted projects to the State to meet the eligibility requirement to receive RMRA funds. If this is not done by July 1, the City loses its eligibility to collect RMRA funding.

The City's required local Maintenance of Effort (MOE) amount to be applied to the project under SB1 is estimated to be \$1,167,244.00, as shown on the table below.

Staff recommends adding the following list of projects to the SB1/RMRA funded projects list so that they can be funded in-part or solely with Fiscal Year 2025-26 Road Maintenance and Rehabilitation Account revenues. These projects involve asphalt roadway maintenance and rehabilitation (mill and overlay, slurry seal), concrete improvements, striping and related work.

#### New Projects which are proposed for the City Council Approval to be listed under SB1/RMRA funding:

Projects in City's FY 2025/26 CIP Program to be listed under SB1 Road Maintenance Program:

Below is a list of all locations for projects listed under SB1 Road Maintenance Program:

Street Rehabilitation – Major Arterial Entrances to the City (Project No: 13655):

- W 2<sup>nd</sup> Street from I-215 Fwy east to Arrowhead Avenue
- N University Parkway from X-walk at N State Street north to Kendall Drive
- S Tippecanoe Avenue from Lee Street north to Mission Zanja Creek north of Hardt Street
- W Baseline Street from Perris Street to Mt Vernin Avenue
- N Waterman Avenue SR210 E/B On/Off Ramps south to Highland Avenue
- E Highland Avenue from Eucalyptus Drive to Robinson Road

Staff recommends appropriate funds in the amount of \$7,352,750.90. Of this, \$5,943,708.00 would come from SB1 funds and \$1,409,042.90 (Maintenance of Effort \$1,167,244.00 plus \$241,802.90) from Measure I funds.

Staff also recommends approval of the attached Resolutions listing proposed projects to be funded under SB1 2025/2026 Road Maintenance Program.

#### **2021-2025 Strategic Targets and Goals**

This project is consistent with Key Target No. 1d. Improved Operational & Financial Capacity - Create a framework for spending decisions and 1f. Create an asset management plan. Approval of the proposed project list will allow staff to move forward in addressing deferred street maintenance needs identified in the pavement management plan, and secure project funding resources available through SB1/RMRA.

### **Fiscal Impact**

There is no General Fund impact associated with this item. A combination of other funds in the amount of \$7,352,750.90 would be used. Of this, \$5,943,708.00 would come from SB1 funds and \$1,409,042.90 (Maintenance of Effort \$1,167,244.00 plus \$241,802.90) from Measure I funds.

### **Conclusion**

It is recommended that the Mayor and City Council of the City of San Bernardino, California,
