Feldheym Central Library at 555 West 6<sup>th</sup> Street, San Bernardino, California. Visit the City's agenda portal at [www.sbcity.org](http://www.sbcity.org) to access more meeting information.  
The purpose of the hearing is to consider the following:  
**SPECIFIC PLAN AMENDMENT 23-02 AND CONDITIONAL USE PERMIT REVISION 23-11** - A request to amend Conditional Use Permit 91-31/Reclamation Plan and the CalMat/Cajon Creek Specific Plan's Design Guidelines governing mining depths and areas; and, allow the consolidation of the City's Reclamation Plan with the County of San Bernardino's Reclamation Plan to establish a combined and updated Amended Reclamation Plan allowing for the continuation of an aggregate mining operation within the San Bernardino County Area Q and City of San Bernardino Areas K, L, M, and N, located Southwest of Cajon Boulevard between Institution Road to the north and Devils Creek Diversion Channel the south, within the Specific Plan—CalMat/Cajon Creek (SP-CC) Industrial Extractive, Ward 6.
