For the Administrative Hearing, members of the public who wish to comment on matters, in lieu of doing so in person, may submit comments by email to: solidwastecomments@sbcity.org by 10:00 a.m, Thursday, May 23, 2024. Approximately 7-14 days following the Administrative Hearing, the Administrative Hearing Decision and Order and Report on the delinquent solid waste collection service charges will be available on the City's website at: <https://www.sbcity.org/AHDO>. The Report will then be submitted to the City Council for confirmation at a Public Hearing.

For the Public Hearing, please refer to the regular meeting agenda of the Mayor and City Council for July 17th, 2024, which will be posted at least 72 hours before the meeting. For the Public Hearing, the Mayor and City Council will receive the Report of delinquent solid waste charges owed to Burrtec Waste Industries ("Burrtec") and shall hear and consider all written or verbal objections or protests, if any, to the Report. You are entitled to address the Mayor and Council at this time. The delinquent charges may be referred to the San Bernardino County Auditor-Controller/Treasurer/Tax Collector and added to other taxes imposed on that parcel and shall constitute a lien against that property. Delinquent charges paid before the hearing will not be referred to the Auditor-Controller/Treasurer/Tax Collector and placed on the tax roll.
