

**RESOLUTION NO. 2025-302**

**RESOLUTION OF THE MAYOR AND CITY COUNCIL OF  
THE CITY OF SAN BERNARDINO, CALIFORNIA,  
AUTHORIZING THE DIRECTOR OF FINANCE AND  
MANAGEMENT SERVICES TO AMEND THE FY2024/25  
THE BUDGET IN REVENUE AND EXPENDITURES BY  
\$5,320 FOR THE SPONSORSHIP PAYMENTS RECEIVED  
TO SUPPORT THE LUNAR NEW YEAR EVENT.**

**WHEREAS**, the Parks, Recreation and Community Services Department hosted a Lunar New Year event on February 1, 2025; and

**WHEREAS**, the Lunar New Year Become A Sponsor application was available online and shared directly with local businesses who expressed interest in sponsoring the event; and

**WHEREAS**, multiple community sponsors responded to the Become A Sponsor solicitation and a total of \$5,320 was raised for the event.

**BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF SAN BERNARDINO AS FOLLOWS:**

**SECTION 1.** The above recitals are true and correct and are incorporated herein by this reference.

**SECTION 2.** The Mayor and City Council hereby authorize the Director of Finance and Management Services amend the FY 24-25 Budget in revenue and expenditure accounts to by \$5,320 for the sponsorship payments received to support the Lunar New Year Event.

**SECTION 3. CEQA.** The Mayor and City Council finds this Resolution is not subject to the California Environmental Quality Act (CEQA) in that the activity is covered by the general rule that CEQA applies only to projects which have the potential for causing a significant effect on the environment. Where it can be seen with certainty, as in this case, that there is no possibility that the activity in question may have a significant effect on the environment, the activity is not subject to CEQA.

**SECTION 6. Severability.** If any provision of this Resolution or the application thereof to any person or circumstance is held invalid, such invalidity shall not affect other provisions or applications, and to this end the provisions of this Resolution are declared to be severable.

**SECTION 7. Effective Date.** This Resolution shall become effective immediately.
