RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF SAN BERNARDINO, CALIFORNIA, AUTHORIZING THE CITY MANAGER TO ACCEPT THE FY 2019 PROJECT SAFE NEIGHBORHOODS GRANT AND AUTHORIZE THE AGENCY DIRECTOR OF ADMINISTRATIVE SERVICES TO AMEND THE FY 2022/23 ADOPTED BUDGET APPROPRIATING \$177,154.51 IN BOTH REVENUE AND EXPENDITURES

WHEREAS, the City of San Bernardino has been awarded the FY 2019 Project Safe Neighborhoods Grant funding in the amount of \$177.154.51; and,

WHEREAS,. The City will use grant funding to deploy Emergency Response Teams to respond to emergency calls and use data-driven impact patrols to help reduce violent crime in the City.

BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF SAN BERNARDINO AS FOLLOWS:

- **SECTION 1.** The above recitals are true and correct and are incorporated herein by this reference.
- **SECTION 2.** The City Manager is hereby authorized to execute the grant agreement between the City of San Bernardino and the Children's Initiative and accept the FY 2019 Project Safe Neighborhoods Grant in the amount of \$177,154.51.
- **SECTION 3.** The Agency Director of Administrative Services is hereby authorized to amend the FY 2022/23 Adopted Budget increasing revenue and expenditures by \$177,154.51.
- **SECTION 4.** That the City Council finds this Resolution is not subject to the California Environmental Quality Act (CEQA) in that the activity is covered by the general rule that CEQA applies only to projects which have the potential for causing a significant effect on the environment. Where it can be seen with certainty, as in this case, that there is no possibility that the activity in question may have a significant effect on the environment, the activity is not subject to CEQA.
- **SECTION 5.** Severability. If any provision of this Resolution or the application thereof to any person or circumstance is held invalid, such invalidity shall not affect other provisions or applications, and to this end the provisions of this Resolution are declared to be severable.
 - **SECTION 6.** Effective Date. This Resolution shall become effective immediately.
