**RESOLUTION OF THE MAYOR AND CITY COUNCIL OF
THE CITY OF SAN BERNARDINO, CALIFORNIA,
AUTHORIZING THE CITY MANAGER OR HIS DESIGNEE
TO EXECUTE AMENDMENT 2 TO PROFESSIONAL
SERVICES AGREEMENT WITH THE PM GROUP DBA
THE PRINTERY IN THE AMOUNT OF \$83,500 FOR THE
DESIGN, PRINT, AND MAIL PREPARATION SERVICES
OF THE CITY OF SAN BERNARDINO PRCSO TRIMESTER
BROCHURE FOR FY2022-2023.**

WHEREAS, the Parks, Recreation, and Community Services Department (PRCSO) provides a diversified system of open spaces, meeting centers, programs and community services to meet social and leisure needs and enhance the quality of life for all city residents; and

WHEREAS, the PRCSO wishes to promote city-wide facilities, programs, and services through a direct mail brochure to the community at large; and

WHEREAS, the City reserves the right to extend the term agreement up to four (4) one (1) year periods in the amount not to exceed 110% of the annual contract amount of \$97,635.

BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF SAN BERNARDINO AS FOLLOWS:

SECTION 1. The above recitals are true and correct and are incorporated herein by this reference.

SECTION 2. The Mayor and City Council hereby authorize the City Manager or his designee, to execute the Professional Services Agreement (PSA) to The PM Group, DBA the Printery, in the amount of \$83,500 for design, print, and mail preparation of the City of San Bernardino PRCSO trimester Brochure.

SECTION 3. The Agency Director of Administrative Services is authorized and directed to issue a purchase order in the amount of \$83,500 to the PM Group, DBA the Printery, for this service.

SECTION 4. The Mayor and City Council finds this Resolution is not subject to the California Environmental Quality Act (CEQA) in that the activity is covered by the general rule that CEQA applies only to projects which have the potential for causing a significant effect on the environment. Where it can be seen with certainty, as in this case, that there is no possibility that the activity in question may have a significant effect on the environment, the activity is not subject to CEQA.

SECTION 5. Severability. If any provision of this Resolution or the application thereof to any person or circumstance is held invalid, such invalidity shall not affect other provisions or applications, and to this end the provisions of this Resolution are declared to be severable.

SECTION 6. Effective Date. This Resolution shall become effective immediately.
