Recommendation:

It is recommended that the Mayor and City Council of the City of San Bernardino, California, adopt Ordinance No. MC-1601 amending Section 19.02.020 (Definitions), Chapter 19.06 (Commercial Zones), and Chapter 19.10 (Industrial Zones) of the City of San Bernardino Municipal Code (Title 19) to update development standards for Commercial Cannabis Activities in accordance with Chapter 5.10 (Commercial Cannabis Activities) City of San Bernardino Municipal Code (Attachment 1); and finding that the Amendment is Exempt under the California Environmental Quality Act.

Background

On November 16, 2022, the Mayor and City Council conducted a public hearing on Development Code Amendment 22-05 to amend Section 19.02.020 (Definitions), Chapter 19.06 (Commercial Zones), and Chapter 19.10 (Industrial Zones) of the City of San Bernardino Municipal Code (Title 19) to update development standards for Commercial Cannabis Activities in accordance with Chapter 5.10 (Commercial Cannabis Activities) City of San Bernardino Municipal Code. Subsequent to the Mayor and City Council discussion, the City Council introduced Ordinance No. MC-1601.

Discussion

Development Code Amendment 22-05 amends Section 19.02.050 within Chapter 19.02, Chapter 19.06, Chapter 19.08, and Section 19.08.030(2)(3) within Chapter 19.08 of Title 19 (Land Use) of City of San Bernardino Municipal Code.

2021-2025 Strategic Targets and Goals

Development Code Amendment 22-05 aligns with Strategic Target No. 4: <u>Economic Growth & Development</u>, under 4(b): <u>Update the General Plan and Development Code</u>. Specifically, the amendment to the Development Code for Commercial Cannabis Activities proposed under Development Code 22-05 will ensure that commercial cannabis activities allowed under Chapter 5.10 of the City's Municipal Code are consistent with the City's land use designations as required by the City's General Plan.

Fiscal Impact

There is no fiscal impact associated with this action.
