Recommendation:

It is recommended that the Mayor and City Council of the City of San Bernardino, California, adopt Resolution 2022-256 authorizing the City Manager or his designee to execute Amendment 2 to Professional Services Agreement (PSA) between the City and the PM Group, DBA The Printery ("Printery"), for the design, print, and mail preparation services of the Parks, Recreation and Community Services Department ("PRCSD") trimester brochure for FY2022-2023.

Background

The Parks, Recreation, and Community Services Department provides a diverse system of open spaces, meeting centers, programs, and community services to meet the social and leisure needs of the public and enhance the quality of life for all city residents. The PRCSD brochure plays a critical role in communicating the department mission to the community.

The brochure of activities provides information and highlights the quality programming offered through the department divisions: Aquatics, Sports, Center for Individual Development, Special Events, Community Centers, Senior Services (including the

Retired Senior Volunteer Program and the Senior Companion Program), and Outdoor Facilities (including picnic areas, community gardens, outdoor sports courts, special play courts, exercise equipment, and sports fields).

Discussion

Most of the City of San Bernardino residents were unaware of all the services provided through the PRCSD. Marketing efforts through social media and other technology-based platforms have not been as effective as printed media in the department's outreach efforts. Recognizing the appeal of the brochures by the community and the positive outcomes in communicating and informing the city's residents at large, the PRCSD is committed to continuing to develop robust brochures, which will serve as a guide for ongoing and seasonal activities, programs, and events. Greater awareness will equate to increased service participation and higher revenues through user fee collection.

Staff recommends the Mayor and City Council authorize the City to execute a one-year extension to the PSA for designing, printing, and mailing the City of San Bernardino PRCSD trimester brochure for FY2022-2023. Under the current agreement (Attachment 4), the City reserves the right to extend the contract up to four (4) additional one (1) year periods, in an amount not to exceed 110% of the annual contract amount of \$97,635, to consider the current volatile price increases due to paper supply shortages due to the COVID-19 pandemic. The FY 2022-2023 PSA with the Printery will not exceed \$83,500.

2021-2025 Key Strategic Targets and Goals

Adoption of this Resolution aligns with Strategic Target No. 2: Focused, Aligned Leadership and Unified Community by providing access to information through the PRCSD brochure, which will boost program participation and community engagement; and Strategic Target No. 3: Improved Quality of Life by serving as a tool to enhance customer service and a primary promotional source for essential PRCSD services and facilities to the community.

Fiscal Impact

The Fiscal Year 2022-2023 adopted budget currently has \$100,500 budgeted for the design, print, and mail of the City of San Bernardino PRCSD trimester brochure.
