Recommendation:

It is recommended that the Mayor and City Council of the City of San Bernardino, California approve the continuation of the Proposition 218 Public Hearing to receive comments on the proposed rate increases and Third Amendment to the City's Exclusive Franchise Agreement for Integrated Solid Waste Collection, Processing and Disposal Services with Burrtec Waste Industries, Inc. ("Burrtec") to the January 17, 2024, Mayor and City Council Meeting.

Executive Summary

At the direction of the City Council at the July 19, 2023 meeting, staff was directed to provide a rate analysis at a future City Council meeting. To provide a third-party analysis of the two proposed options, Options A and B, staff solicited proposals from Solid Waste Rate consultants. Staff entered into an agreement with R3 Consulting Group, Inc. to conduct the rate analysis. In order to conduct a thorough analysis, staff is requesting a continuation of the Proposition 218 Public Hearing to January 17, 2024.

Background

On July 19, 2023, the City Council continued the Proposition 218 Public Hearing to

September 6, 2023. The basis of the continuation was to direct staff to provide an analysis of the proposed rates of Options A and B. The proposed rates for Options A and B are as follows:

Option	Proposed Rate
A	\$36.17
B	\$30.71

Discussion

To provide a third-party independent rate analysis, staff solicited quotes from rate consultants to review the two rate options. Staff has retained R3 Consulting Group to conduct the rate analysis and provide draft Franchise Agreement Amendment language based on the analysis. The agreement with R3 Consulting Group is in the amount of \$35,000 and authorized by the Interim City Manager consistent with the City's purchasing guidelines.

This requires additional time to finalize the proposed option and to prepare for a thorough presentation on rates for the City Council. Staff intends to provide the City Council with the analysis of the two proposed rates options at the January 17, 2024, meeting.

Staff is working closely with the City Attorney's office to ensure compliance with the original Proposition 218 notice.

2021-2025 Strategic Targets and Goals

A Public Hearing to consider adjusting the Maximum Permitted Services Rates, as well as the amendment of the Franchise agreement between the City and Burrtec, meets Key Target No. 3c: Improved Quality of Life by evaluating and enhancing the quality of public safety services and Key Target No. 3d: To improve the City's appearance, cleanliness, and attractiveness.

There will be no costs incurred to the General Fund with this action.
